Afterschool activity buses are scheduled to begin running on **Monday, September 28th, 2015**. HIMS student participating in **school authorized programs** are welcome to ride an ASA bus with parent/guardian permission. Buses depart from HIMS at 4:45 pm. **NOT ALL NEIGHBORHOODS ARE SERVED**. If your neighborhood is NOT served your student may receive a Metro bus token. The SPS transportation department needs 7-10 working days to assign an after-school bus route.

Please note that a student's regular school bus and stop **IS NOT** always the same during after-school activities. Activity buses will run Monday through Thursday on the following dates (excluding school breaks and Early Release days: 9/23, 10/28, 11/25, 1/13, 3/23, & 6/1)

- HOST Fall Activity Buses will run Sept. 28h - December 10, 2015
- HOST Winter/Spring Activity Buses will run Jan 19th - June 9th, 2016

**Activity buses will not run EARLY DISMISSAL days & are subject to cancellation during inclement weather.**
